

# Molina Healthcare STAR+PLUS value- added services



**At Molina Healthcare, we care about your health. That's why we offer member rewards so you can get the quality care and support you need to stay healthy. All at no cost to you!**

Benefits are effective as of September 1, 2025.



**\$120 for OTC medicines and supplies:** \$30 reward every three months for over-the-counter medicines and other medical or health-related supplies not covered by Medicaid. Up to \$120 annually. Available for non-dual members, upon request. Cannot be used to buy food or water.



**24/7 emergency response services:** For non-waiver members 21 and older who require this service. Must be authorized by a Molina Service Coordinator. Does not apply to Community First Choice members.



**Dental services:** Up to \$250 per year for dental checkups, x-rays and cleaning for members ages 21 and older. Available upon request.



**\$30 behavioral health reward:** For non-dual members who have an office visit with a behavioral health specialist within seven days of a hospitalization for a mental health condition. Members who visit their doctor within 7 days of hospitalization can get an extra \$30 for visiting their doctor again within 30 days of hospitalization for a mental health condition. Available upon request and must be verified.



**\$20 for mammograms:** For non-dual female members ages 50–74 who get a recommended mammogram. Available once a year, upon request. Must be verified.



**\$50 for cervical cancer screenings:** For non-dual female members ages 21–64 who get a recommended cervical cancer screening. Available upon request. Must be verified.



**\$25 for diabetic eye exams:** For non-dual diabetic members ages 18–75 who get an annual diabetic eye exam. Available once a year, upon request. Must be verified.



**Dietitian visits:** Diabetic non-dual members 21 and older get four visits a year with a registered dietitian. Service available upon request.



**\$80 for HbA1c testing:** \$20 reward for getting an HbA1c lab test every six months. For diabetic non-dual members. An extra \$20 reward is available every six months for having an A1c less than 8. Lab testing and results must be verified. Available upon request.



**\$25 for having follow-up visits after hospitalization:** For non-dual members who have a follow-up doctor visit within 30 days of hospital discharge. Available once per year. Must be requested and service must be verified.



**Tote bag:** Available once, for newly enrolled members, upon request.



**WeightWatchers® vouchers:** For diabetic members with a BMI of 30 or higher or an A1c of 8 or more. Molina will determine the total number of meeting vouchers provided. Available for non-dual members, upon request.



**Body weight scale:** Available once per year for non-dual members with congestive heart failure. Must be requested.



**Home-delivered meals:** Up to ten healthy meals delivered to your home for members discharged from an inpatient hospital stay or skilled nursing facility. For non-waiver members, aged 21 and older. Available once a year, upon request. Must be authorized.



**Home visits:** Up to eight hours of respite services are available each year to non-waiver members, aged 21 and older, who require care due to the absence of or need for relief of their unpaid caregiver. Available upon request. Must be authorized by a Molina Service Coordinator.



**\$100 eyewear allowance:** Can be used for frames, lenses or contacts every two years. Available to non-dual members every two years, upon request.



**Allergy-free pillowcase and mattress cover:** For members with asthma or COPD who are enrolled in Molina's Care Management Program for at least three months. Available once per year upon request. Must be authorized by a Molina Service Coordinator.



**Pest repellent wall plugs:** For members with asthma or COPD who are enrolled in Molina's Care Management Program for at least three months. Available once per year upon request.



**\$50 for prenatal exams:** For newly enrolled pregnant members who get an early prenatal exam within 42 days of enrollment. Current members who complete an early prenatal exam in the first trimester (90 days) also qualify. Available for non-dual members upon request. Must be confirmed by an OB/GYN or primary care provider.



**\$50 for postpartum exams:** For members who get a postpartum exam within 7–84 days of delivery. Available for non-dual members, upon request. Must be verified.



**One infant car seat:** For members in their sixth month of pregnancy through six months after delivery. Available upon request.



**Postpartum kit:** New moms can request a postpartum kit for up to three months after delivery. Once every year, upon request.



**\$25 for continuing diabetes medication:** For diabetic members, aged 40–75, who refill at least one statin medication. Available to non-dual members once per year upon request. Must be verified.



**Extra \$25 for continuing diabetes medication:** For diabetic members, aged 40–75, who stay on their statin medication for at least 10 months in a row, beginning on September 1, 2025. Available to non-dual members once per year, upon request.

 **\$25 for heart disease medication:** For male members aged 21–75, and female members aged 40–75, who have atherosclerotic cardiovascular disease and refill at least one statin medication. Available to non-dual members once a year, upon request.

 **Extra \$25 for heart disease medication:** For male members aged 21–75 and female members aged 40–75 who have atherosclerotic cardiovascular disease and continue statin medication for at least 10 months in a row, beginning September 1, 2025. Available to non-dual members once per year, upon request.

 **Fitness tracker watch:** \$50 value. For non-dual members who complete a WeightWatchers® program. Available once per year upon request.

 **\$25 for kidney evaluations:** For diabetic members, aged 18–85, who get an annual kidney health evaluation and a urine albumin-creatinine ratio (uACR). Available to non-dual members once a year, upon request.

 **\$25 for corticosteroid:** For members, aged 40 and older, who fill a systematic corticosteroid prescription within 14 days of an inpatient hospital discharge or an Emergency Room visit for COPD. Available for non-dual members once per year, upon request.

 **\$25 for a bronchodilator:** For members aged 40 and older who fill a prescription for a bronchodilator within 30 days of an inpatient hospital discharge or an Emergency room visit for COPD. Available for non-dual members once per year, upon request.

 **GED study guide:** For members with an IDD diagnosis. Available one time only, upon request.

 **Telephone and mobile-app resources:** Available through Pyx Health to support and connect members who may feel lonely, sad or anxious.

 **Exercise kit with resistance bands:** For diabetic members with a BMI of 30 or more or an A1c of 8 or more. Available upon request.

 **\$15 gas reward:** For members to go to WIC offices, food pantries or community centers. Once per year, upon request.

**Must be currently enrolled at the time of your medical service to qualify for the reward.**
